Erie Township Meetings and Commissions Fee schedule

All regular scheduled meetings require the review and approval fees as outlined below plus an escrow deposit as stated. If a Special Meeting is requested the special meeting fee shall be added to the regular fees. The fees are non-refundable and cover township administrative costs. In addition escrow fees are required as stated to cover the costs (plus 10% administration) for outside review, engineering, inspection, legal fees, etc. The applicant is responsible for paying all additional administrative, consultant and outside fees that the escrow deposit does not cover. The Township, at its discretion, may require additional escrow fees as they deem it necessary.
