CALL TO ORDER:

The regular meeting of the Erie Township Board was held Tuesday, December 10, 2019 at the Erie Township Hall, 2065 Erie Rd. Erie, Michigan. Clerk Kim Cousino called the meeting to order at 7:00 pm. The roll was called, and the Pledge of Allegiance recited.

C. Wisbon motioned to appoint K. Cousino as chair for the meeting. G. Wilmoth supported. Motion Carried.

Resident Josh Gray from Lotus Dr. spoke regarding the illegal dumping that keeps occurring on Lotus Dr. Resident is requesting signs to be placed stating a fine should be charged if caught and has also offered to donate towards the purchase of signs and volunteer his own time to place them. The board acknowledged that the township is aware of the illegal roadside dumping on Lotus and other areas of the township, there is a fine if caught dumping, and cameras have been placed.

5) Township Insurance Renewal:

K. Cousino stated that the township property and liability insurance is provided through Decker Insurance Agency, with Michigan PAR Plan. Quotes were received for cyber liability being an additional \$1,499 for the year and increased inland marine coverage for an additional \$569.

G. Wilmoth motioned to renew the township insurance policy with Michigan PAR Plan, keeping the coverage the same, in the amount of \$32, 467.00. C. Wisbon supported. Roll called. K. Cousino – yes, C. Wisbon – yes, G. Wilmoth – yes. Motion Carried.

6) Observation Wells Located on Township Property:

A letter was received from the US Department of Interior regarding observation wells located on Erie Township Property. The wells are located at South Erie Park and on Telegraph Rd just north of Erie Rd. The letter is requesting Clerk Cousino to sign the well transfer agreements transferring the ownership of the two wells from the U.S. Department of Interior to Erie Township. In 1995 Supervisor Margaret Duesseau sent a letter requesting the transfer of ownership but an original signed agreement is not on file.

G. Wilmoth motioned to authorize K. Cousino to sign the observation well transfer agreement with US Department of Interior. C. Wisbon supported. Motion Carried.

7) Resignation of Township Office Secretary Jackie Cowdrey:

C. Wisbon motioned to accept the resignation of Jacqueline Cowdrey as Erie Township office secretary with regrets. K. Cousino supported the motion. Motion Carried.

8) Hiring of Township Secretary:
