

ERIE TOWNSHIP ORDINANCE NO. 122

**ERIE TOWNSHIP PROHIBITION OF  
MARIHUANA ESTABLISHMENTS ORDINANCE**

An Ordinance enacted pursuant to Act 246 of the Public Acts of 1945, as amended, and the Michigan Regulation and Taxation of Marihuana Act to prohibit marihuana establishments pursuant to Section 6(1) of the Michigan Regulation and Taxation of Marihuana Act; to provide for the public health, safety, and general welfare of the persons and property of the Township of Erie; and to repeal all other Ordinances, parts of Ordinances, codes, or regulations in conflict hereof.

**THE TOWNSHIP BOARD OF THE TOWNSHIP OF ERIE, COUNTY OF MONROE, STATE OF MICHIGAN, ORDAINS:**

**SECTION 1. SHORT TITLE.**

This Ordinance shall be known and referred to as the "Erie Township Prohibition of Marihuana Establishments Ordinance".

**SECTION 2. PURPOSE.**

This Ordinance is adopted for the purpose of prohibiting marihuana establishments within the boundaries of Erie Township and to provide for the public health, safety, and general welfare of the persons and property of the Township of Erie.

**SECTION 3. PROHIBITION.**

Pursuant to Section 6(1) of the Michigan Regulation and Taxation of Marihuana Act, Erie Township elects to prohibit marihuana establishments within its boundaries.

**SECTION 4. SEVERABILITY.**

This Ordinance, and the various parts, sentences, paragraphs, sections, subsections, phrases and clauses hereof, are hereby declared severable, and if any of them are judged unconstitutional or invalid, it is hereby declared that the remainder of the Ordinance shall not be affected.

**SECTION 5. INCONSISTENT ORDINANCES REPEALED.**

All Ordinances or parts of Ordinances in conflict with this Ordinance, are to the extent of such conflict, repealed.

**SECTION 6. EFFECTIVE DATE.**

This Ordinance shall become effective thirty (30) days after it, or a summary of it, is published in a newspaper of general circulation in the Township of Erie. This Ordinance, or a summary of it, shall be published in a newspaper of general circulation in the Township of Erie within thirty (30) days after its adoption.
