#### ERIE TOWNSHIP ORDINANCE No. 66

An ordinance to promote the safety and welfare of people using Erie Township Parks by prohibiting the use and/or consumption of alcoholic beverages within said parks after the hour of 10:00 p.m., and providing penalties for the violating of the provisions hereof.

THE TOWNSHIP OF ERIE, MONROE COUNTY, MICHIGAN, HEREBY ORDAINS:

### SECTION 1.

It shall be unlawful for any person or persons to use and/or consume any alcoholic beverage within the boundaries of any Township Park in Erie Township after the hours of 10:00 p.m. each day and before the hours of 9:00 a.m. of the following day.

### SECTION 2.

Any person or persons who shall violate the provisions of Section 1 of this Ordinance shall be guilty of a misdemeanor and upon conviction thereof shall be subject to a fine of not more than one hundred (\$100.00) dollars, or imprisonment in the Monroe County Jail for a period not to exceed ninety (90) days, or by both such fine and imprisonment in the discretion of the Court.

#### SECTION 3.

All other ordinances or parts of ordinances of the Township of Erie, in conflict herewith are hereby repealed.

# SECTION 4.

This Ordinance shall be in full force and effect thirty (30) days after publication, and shall be published in the Monroe Evening News, a newspaper circulating within said township within thirty (30) days after passage.

An ordinance to promote the safety and welfare of people using the Erie Township Parks by prohibiting the Loitering or Assemblage of person(s) on Township Parks or Parking lots immediately adjacent thereto after the hours of 11:00 P.M. each day and before the hours of 6:00 A.M. of the following day, and providing penalties for the violating of the provisions hereof.

THE TOWNSHIP OF ERIE, MONROE COUNTY, MICHIGAN, HEREBY ORDAINS:

# SECTION 1.

It shall be unlawful for any person or persons to use/or occupy any Township Park or Parking lot(s) immediately adjacent thereto after the hours of 11:00 P.M. each day and before the hour of 6:00 A.M. of the following day without first obtaining special use permit from the Township by making application to the Township Clerk.

### SECTION 2.

Any person or persons who shall violate the provisions of Section 1 of this Ordinance shall be guilty of a misdemeanor and upon conviction thereof shall be subject to a fine of not more than one hundred (\$100.00) dollars, or imprisonment in the Monroe County Jail for a period not to exceed ninety (90) days, or by both such fine and imprisonment at the discretion of the Court.

#### SECTION 3.

All other ordinances or parts of ordinances of the Township of Erie, in conflict herewith are hereby repealed.

# SECTION 4.

Definition: For purpose of this ordinance, the term use or occupy shall include the standing or loitering of any person(s) on any Township Park or Parking lot or Township road immediately adjacent to the entrance of any Township Park including but not limited to the parking of any vehicle whether motor driven or not, the physical trespass on any Park property or parking lot, no matter how slight.

#### SECTION 5.

This Ordinance shall be in full force and effect thirty (30) days after publication, and shall be published in the Bedford Courier, a newspaper circulating within said Township within thirty (30) days after passage.
