Jackie Cowdrey provided a copy of the contract with Laser Striping LLC, they honored the original estimate of \$20,900, they require half up front, cost will come out of the repair & maintenance line. Jackie will ask Laser Striping the timeframe they can schedule the work and how long do we need to stay off the courts.

Kim Cousino stated that the port-john contract needs to be renewed this year and asked the commissioners to consider leaving one unit year-round at South Erie Park and Maplewood Park, also Danny Taylor asked for two signs be installed at South Erie Park that read "NO OFF-ROAD VEHICLES".

Diane La Plante moved supported by Jackie Cowdrey, to purchase two no off-road vehicle signs for South Erie Park. Motion carried.
