### **E. BUSINESS:**

### 1) Representative from Mason Consolidated Schools:

Mason middle school principal, Ben Russow, and Mason Consolidated Schools board member, Pat Larrow, were present to speak to the public regarding the May 2<sup>nd</sup> election.

### 2) Bills Approval:

C. Wisbon made the motion to approve checks #36228 - #36274 from the general fund including payroll, ACH & EFT in the amount of \$119,664.19. Check #1675 - #1676 from the Trust and Agency account in the amount of \$618.00. K. Cousino supported the motion. Roll was called C. Wisbon – yes, P. Perry – yes, G. Wilmoth – yes, S. ### 3) Public Hearing: Streetman St. Streetlight Special Assessment District:

A request was received for one more streetlight to be added near the address of 965 Streetman. The cost is \$100.00 for the installation of a 40-watt LED cobrahead light. There are 26 parcels in the district, the cost for installation and use will be equally assessed to each parcel. A resident from the district stated that area doesn't need a light, he said the intersection of Preston & Streetman needs a light. Discussion was held.

Barry Bushmann was present from Mannik & Smith Group to present the contract for the downtown Erie improvement project and spoke regarding Erie Township being awarded the SEMCOG TAP Grant in the amount of \$335,712, as well as \$50,000 from Ralph Wilson Legacy grant. Mannik & Smith's engineering fees for the project are estimated to be \$105,400. Discussion was held.
