The regular meeting and public hearing of the Erie Township Board was held Tuesday, July 11, 2023, at the Erie Township Hall, 2065 Erie Rd. Erie, Michigan. D. PUBLIC COMMENT:

Diane LaPlante thanked the Erie Police Department for great job, with special recognition to Officer Derwoed.

30th District House Representative William Bruck spoke regarding Bill No. 4845 to rename a portion of South Dixie Highway between Albain Rd and Dunbar Rd in memory of Captain Joe Liedel. Mr. Bruck also spoke regarding Bill No. 4741 which will reimburse townships for Veterans that qualify for property tax exemption. He also stated that he will be holding a coffee hour on July 17, 2023 at Decapo from 7:30am to 9:30am.

E. BUSINESS:

1) Bills Approval:

C. Wisbon made the motion to approve checks #36441 - #36510 from the general fund including payroll and ACH & EFT in the amount of \$121,317.59. Nothing from the Trust and Agency account. K. Cousino supported the motion. Roll was called C. Wisbon – yes, P. Perry – yes, S. Mishka – yes, K. Cousino – yes. Motion carried.

2) Public Hearing for Maplewood Special Assessment District, Morin Grove Special Assessment District, Petee's Colony Special Assessment District, Matty Drive Streetlight Special Assessment District:

P. Perry motioned to close the regular board meeting at 7:08pm. K. Cousino supported. Motion carried.

P. Perry motioned to open the public hearings for the special assessment districts of Maplewood, Morin Grove, Petees Colony, and Matty Drive streetlighting. K. Cousino supported. Motion carried.

Maplewood Special Assessment District Public Hearing:

Maplewood Special Assessment District is currently at \$300 per year per parcel, there are 66 parcels.

Sandy Dobbs suggested going back to \$100.00 per year per parcel.

Danny Taylor agreed with the decrease to \$100.00 per year per parcel.

The Board received a letter from resident and property owner in Maplewood, Jay Bowman, requesting the assessment be brought back down to \$100 per year per parcel.

Morin Grove Special Assessment District Public Hearing:

Morin Grove has 28 parcels which are currently assessed at \$100.00 per year. No one from the Morin Grove district was present for comments.

Petees Colony Special Assessment District Public Hearing:

Petees Colony is currently at \$100 per parcel per year with 12 parcels. Current Balance is \$5,678.64. Scott Cerveny who is a resident and property owner of Shallow Creek spoke regarding the possibility of combining Petees Colony Special Assessment District with Morin Point West Special Assessment District.

Matty Drive Streetlight Special Assessment District Public Hearing:

Matty Drive Streetlight Special Assessment District will be established for the installation of one streetlight, either on existing the pole and suspend over South Dixie Highway or a new pole will be installed to suspend over Matty Drive. The cost of installation is \$100 and the approximate cost for electric use is \$145 for the year. First year would be \$35 per parcel and each year after would be \$21 per parcel.

Bernie Russel, Sharon Grodi and Manny Evola spoke regarding the placement of the light and agreed that it should be placed on the existing pole, suspended over South Dixie Highway.

P. Perry motioned to close the public hearings for the special assessment districts at 7:34pm. K. Cousino supported. Motion carried.
