S. Mishka moved, supported by C. Wisbon to approve the purchase of an LED digital sign from Graphic Signs in the amount of \$33,400; the purchase will be funded with ARPA funds. Motion carried on a roll call vote, all in favor.

12) Competitive Bidding Policy

C. Wisbon moved, supported by P. Perry to approve the resolution establishing the competitive bidding policy, increasing the estimated minimum bid to \$20,000. Motion carried on a roll call vote, all in favor.

13) MCRC Sign Shop Cost for 'No Engine Brake' Signs on Luna Pier Rd.:
